

Liability Disclaimer

SANDBANK & SECRET ISLAND

Participation at Own Risk

I acknowledge that I am participating in the Sandbank/Secret Island event at my own responsibility and risk. I am aware that boating, traveling to and from the sandbank, and engaging in activities on the sandbank can involve risks such as injury, falls, property damage, accidents, or other unforeseen events.

Health Requirements

I confirm that I am in adequate physical health to safely participate in the Event. Should there be any uncertainty about my physical condition, I will inform the organizers as soon as possible.

Personal Responsibility and Instructions

I agree to follow all instructions given by the boat crew, organizers, security staff, and any rescue teams involved in the Event. I understand that failure to comply with these instructions may result in my exclusion from the remainder of the Event without any refund.

Liability Exclusion of the Organizers

I agree that the organizers (including their employees, representatives, and agents) shall be exempt from any liability claims arising from damages or injuries occurring during the Event, unless caused by the organizers' willful misconduct. This exemption specifically includes: injuries of any kind (including consequential damages), damage to or loss of personal property, damages caused by force majeure, unforeseeable natural events (tides, weather changes), or actions of third parties.

Personal Belongings and Insurance

I acknowledge full responsibility for my personal belongings (money, phone, camera, etc.) and understand that the organizers do not provide or assume responsibility for personal item insurance or travel insurance of any kind. I confirm that I have adequate health and accident insurance to cover any potential risks.

Consent to Photo and Video Recordings

I agree that photos and videos may be taken during the Event in which I may appear. These images may be used by the organizers for promotional or documentation purposes. If I have any concerns about this, I will inform the organizers on site.

Applicable Law

This liability waiver is governed by the laws of the location where the Event takes place. That means the laws and regulations of that country or region apply to the interpretation and enforcement of this waiver.

Alcohol and Drug Consumption

I understand that consuming alcohol or other intoxicating substances before or during the Event may affect my judgment and physical abilities. If the organizers or boat crew determine that my condition could endanger my own safety or the safety of others, they may, at their discretion, restrict my participation or ask me to leave the Event without refund.

Weather and Tide Conditions

I understand that weather and tide conditions can change rapidly and that the organizers reserve the right to adjust the schedule, change the route, or cancel the Event if conditions pose a safety risk. I acknowledge that in the event of a weather- or tide-related adjustment or cancellation, there may be no or only partial refunds, depending on the organizers' policy. I further agree to follow the organizers' instructions at all times, especially if conditions change unexpectedly.

Responsibility for Damages to the Boat and Equipment

I agree to treat the boat, its equipment, and any rental gear with care. I understand that I may be held financially responsible for damages caused by my misuse or reckless behavior. I further acknowledge that if I disregard any safety instructions or mishandle equipment, the organizers reserve the right to exclude me from the Event without any refund.
